Sir/Ma'am,

This is with reference to the video conferencing today on 12-03-2020 with Sh. Sanjeeva Kumar, Additional Secretary, Ministry Of Health & Family Welfare, Govt. of Nirman Bhawan, Delhi regarding provision of Quarantine and Isolation facilities at International Airports for CoVid-19. In this connection I am directed to request you to identify quarantine and isolation facilities for COVID-19 near Airports as per the following instructions:-

1. The **quarantine facilities** may be any public utility like Marriage house, Haj house, Dharamshala, Schools etc. having maximum numbers of beds. The identified quarantine facilities must be in proximity to the airport and with designated hospital for isolation. The quarantine facilities may kindly be identified indicating name of the facility/building of beds and its distance with the identified hospitals.

2. Further the **isolation facilities** in the designated hospitals with number of beds and its proximity to the Airport may also be identified and kept ready.

In view of the above, it is therefore requested to provide the details of the quarantine and isolation facilities to the Ministry of Health and Family Welfare, Govt. of India by evening.
